Notice from the State Council on Popularizing the Replicable Reform Pilot Experience of China (Shanghai) Pilot Free Trade Zone

GF [2014] No. 65

People's governments of all provinces, autonomous regions and municipalities directly under the Central Government, the ministries and commissions and directly affiliated institutions under the State Council:

Setup of China (Shanghai) pilot free trade zone (hereinafter referred to as Shanghai pilot free trade zone) is an important decision made by the Party Central Committee and State Council. The municipal and relevant departments of Shanghai pilot free trade zone take streamlining administration and delegating power to the lower levels and delegating power and strengthening regulation combined system innovation as the core, speed transformation of governmental functions, explore innovation of the system and mechanism, and form a batch of reform and innovation achievements which can be replicated and popularized in the aspects of establishing the trade supervision system taking the negative list management and trade facilitation as the focus, the financial innovation system taking the capital account convertibility and financial service industry opening as the objective, and government function in-process and post-supervision system and others. Approved by the Party Central Committee and State Council, Shanghai pilot free trade zone can be replicated and popularized. The relevant issues are hereby notified as follows:

I. Main content which can be replicated and popularized

The replicable reform pilot experience of Shanghai pilot free trade zone can, in principle, be popularized to somewhere else of the whole country except the items involved in law revision and Shanghai International Financial Center construction. Relevant departments, by combining their own various jobs in deepening the reform, have replicated and popularized a batch of experience and practice nationwide. Following items are popularized:

- (I) Reform items replicated and popularized nationwide.
- 1. Investment management field: foreign invested advertisement enterprises project filing system, tax related items online approval and filing, tax registration number online automatic number assignment, online self-service handling, online credit rating, organization code real-time number assignment, corporate standard filing management system innovation, canceling production certificate consigned processing filing, and enterprises setting up and implementing the "single window" work scheme.
- 2. Trade facilitation field: global maintenance industry inspection and quarantine supervision, management of certificate of origin of transshipped goods, paperless customs clearance of inspection and quarantine, third party inspection results admission, entry and exit chemical materials and products risk management and others.
- 3. Finance field: RMB settlement business under personal other current items, foreign-invested enterprises foreign exchange capital voluntary foreign exchange settlement, foreign exchange settlement and sale involved in bank handling bulk commodity derivative counter transaction, foreign exchange registration and registration change under direct investment item delegated to the bank for transaction and others.
- 4. Service industry opening field: allow the lease finance company to operate the commercial factoring business related to the main business as the sideline, allow setup of the foreign-invested credit investigation company, allow setup of the shareholding system foreign-invested investigation company, allow the lease finance company to set up subsidiaries without setting the lowest registration capital limit, allow the domestic and

foreign-invested enterprises to engage in games and recreation device production and sales and others.

- 5. In-process and post-supervision system: social credit system, information sharing and comprehensive law enforcement system, enterprise annual report and announcement and operation exception list system, social force and specialty supervision system of each department.
- (II) Reform items to be replicated and popularized in other customs special supervision areas nationwide.
- 1. Customs supervision system innovation: futures bonded delivery customs supervision system, domestic and foreign maintenance customs supervision system, finance lease customs supervision system and other measures.
- 2. Inspection and quarantine system innovation: imported goods pre-inspection, branching supervision and management system, flora and fauna and their product quarantine approval negative list management and other measures.
 - II. Pay high attention to popularizing work.

All areas and department shall be profoundly aware of the significance of the replicable reform pilot experience of Shanghai pilot free trade zone, take the popularizing work as the government management concept for comprehensively deepening reform, to promote reform by opening up, focus on solving imperfect market system, excessive government intervention and poor supervision and others problems taking into account the actual conditions of their own areas and departments, to play the decisive role and government role in resources allocation. Adapt to the trend of economic globalization, build the new system bonus suitable to our open type economic development requirements gradually, to promote orderly and free flow of international and domestic factors, efficient allocation of resources and market deep integration, speed up fostering the new advantages of participating in and leading international economic cooperation and competition.

III. Do a good job in organization and implementation

The people's government of all provinces (districts, cities) shall adjust measures to local conditions, list the popularizing relevant system and mechanism reform measures as the focus of their own regions, establish and perfect the leadership mechanism, and carry out proactively, to ensure that the reform pilot experience is implemented and produce actual effect. Relevant departments of the State Council shall complete relevant reform pilot experience popularizing work as per the specified time limit. All provinces (all relevant departments of the State Council shall formulate the work scheme, to define the specific tasks, time node and achievement form which can be inspected, and send to the Commerce Department before January 31, 2015.Major problems encountered during the reform pilot experience popularizing process shall be reported to the State Council in time.
